DOCUMENTS REQUIRED WITH THE PERMIT APPLICATION

- **Plans** and **details** of the **proposed work**. Details shall comply with City Standards.
- Contractors shall have the following **insurance**:
 - \$1 Million Liability
 - \$1 Million Workers' Compensation for Contractors
 - \$1 Million for Auto
 - \$2 Million Combined Aggregate
 - In the "**Certificate Holder**" location, list the **City of Half Moon Bay**, 501 Main Street, Half Moon Bay, CA 94019.

• All businesses (e.g. contractors, sub-contractors, designers, etc) that conduct business in the City of Half Moon Bay are required to have a valid business license while working within the City.
